They will carry on for years and decades to come in the wetlands, meadows, natural shorelines, and forests now under Kawartha Land Trust’s care. The ecosystems that you helped permanently conserve will remain protected and cared for long into the future.

Message from the Executive Director

You were there for nature in 2024. I know that because we were able to protect six new properties through your generous support, bringing Kawartha Land Trust’s total protected lands to over 8,200 acres. Our newest protected lands join KLT’s others as emblems of hope on the landscape and a testament to what we can achieve together to protect nature.

You were there for nature in 2024. I can say that again because of the many stewardship projects that your gifts supported. Staff and volunteers planted trees, removed invasive plant species like Invasive Phragmites, continued restoration work at our tallgrass prairie, and conducted plant and wildlife surveys to better know the biodiversity on our protected lands and how best to support them.

Our growing Partners in Conservation (PIC) program reached 100 members — an accomplishment we couldn’t have achieved without your support. KLT’s Partners in Conservation care for over 11,000 acres of land in the Kawarthas. In 2024, we collaborated on 60 projects with landowners to support nature on our shared landscape, including wetland restoration projects.

Last year, a group of concerned citizens reached out to KLT about protecting a property adjacent to the Jeffrey-Cowan Forest Preserve on the north shore of Ston(e)y Lake. What ensued was an exciting summer-long campaign led by a passionate volunteer fundraising team who literally paddled the lake to talk to raise pledges. A final push at the end of the summer put us over the top and the property is now protected for future generations.

In early fall, under sunny skies in Douro-Dummer, we opened our memorial forest. Located in the Roussel-Steffler Memorial Sanctuary, which was generously donated to KLT by the Roussel-Steffler family in 2023, the memorial forest is a peaceful place to remember loved ones who have passed. The trees, shrubs, and wildflowers we planted last year and in coming years will grow into a thriving forest ecosystem.

There were so many moments in 2024 where I was able to pause and reflect on the contributions you’ve made for nature and these are just a few. We hope that as you read through this report, you see the lasting impact you have made for nature in the Kawarthas. And for that, I thank you.

KLT Properties Protected in 2024

CEA Properties (Conservation Easement Agreements)

A. Plant CEA

Located in Selwyn Township, the Plant CEA is a 79-acre property that is home to a beautiful hardwood forest, lively hedgerows, and 36 acres of vital agricultural lands — lands that because of the easement will remain in production on the landscape for current and future generations.

We're grateful to Dick and Susan Plant for partnering with KLT to protect nature and farmland in the Kawarthas for future generations and to Environment and Climate Change Canada's (ECCC) Nature Smart Climate Solutions Fund (NSCSF) for supporting the protection of this land.

B. Maitman-Sutton CEA

Thanks to the long-term thinking and vision of Mark Maitman and Dale Sutton, 56 acres of natural lands in the City of Kawartha Lakes is protected for future generations through a conservation easement agreement. The property's deciduous forest, mixed swamp, and meadow will continue to contribute to natural climate solutions in the region and support native wildlife and plant species like Sugar Maple, Brown Thrasher, Common Milkweed, at-risk Monarch Butterfly and many others. We offer our thanks to Environment and Climate Change Canada's (ECCC) Nature Smart Climate Solutions Fund (NSCSF) for supporting this conservation project.

New KLT Nature Reserves

1. Theresa Hickey Perry Nature Sanctuary (property location not displayed)

This 1.5-acre lakeside nature sanctuary was generously donated to Kawartha Land Trust by Jane Zeidler to ensure its permanent protection. The donated land is 100% natural and features 125 metres of important natural shoreline along Ston(e)y Lake, iconic rock barrens, towering Eastern White Pines, White Oak, and Juniper.

2. Ston(e)y Lake Family Forest

In 2024, a team of dedicated volunteers led a fundraising campaign to protect a property adjacent to KLT's Jeffrey-Cowan Forest Preserve on the north shore of Ston(e)y Lake. Over three hundred generous individuals and families donated to the summer-long campaign to ensure the permanent protection of 10.5 acres of forest and 200 metres of natural shoreline along Ston(e)y Lake.

3. MapleCross John Wolfe Forest Preserve

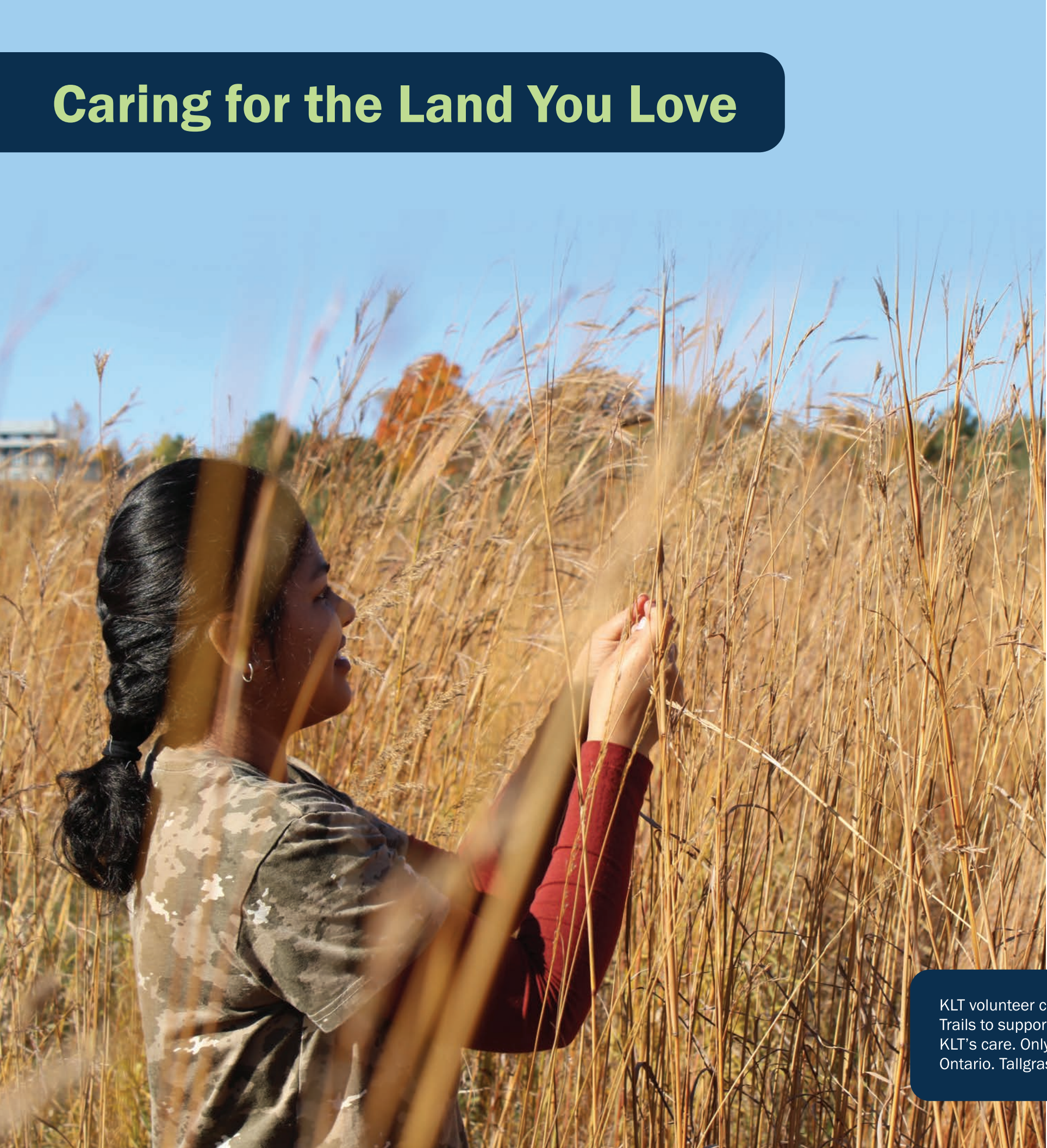
This 751-acre nature reserve was established at the end of 2024 thanks to the generous support of the Wolfe Family, donors like you, MapleCross Fund, Echo Foundation, Environment and Climate Change Canada's (ECCC) Natural Heritage Conservation Program — Land Trusts Conservation Fund (NHCP-LTCF), and Environment and Climate Change Canada's (ECCC) Nature Smart Climate Solutions Fund (NSCSF).

One hundred percent of the property is considered deep habitat or interior forest. In a time of increased fragmentation of forest ecosystems in Southern Ontario, the protection of interior forest habitat is essential for species that require large, unbroken, tracts of natural land to survive and thrive.

4. Extension to Ballyduff Trails

KLT has a long and inspiring relationship with land donors Ralph McKim and Jean Garsonnin. In 2011, they protected their Pontypool property through a Conservation Easement Agreement. In 2021, they generously donated 157 acres of the property to KLT, which included expansive forests, community trails, and a rare tallgrass prairie. In 2024, Ralph and Jean completed a severance of their home and donated another 71-acres to KLT to protect in perpetuity. We're grateful for their passion for nature and for Environment and Climate Change Canada's (ECCC) Natural Heritage Conservation Program — Land Trusts Conservation Fund's (NHCP-LTCF) for supporting this project.

Caring for the Land You Love



In 2024, your gifts not only protected lands that were at risk to unsustainable development, but they also cared for KLT’s protected lands and supported nature through KLT’s Partners in Conservation program. It would be impossible to share all of the projects that you made possible last year, but we’d like to provide some highlights to show how your gifts are making a difference for nature.

In 2024, your gifts ensured:

- **The collection of an astonishing 28 kg of tallgrass seeds** to support the restoration and expansion of KLT’s rare tallgrass prairie at Ballyduff Trails.
- **The enhancement of 20 acres** of endangered prairie and savanna.
- **The planting of 750 native trees and shrubs** to support natural climate solutions in our region.
- **The restoration or enhancement of almost 50 acres of wetlands** to support vital wildlife habitat.
- **Over 100 fieldwork outings to monitor and manage invasive plant species** like Common Buckthorn, Invasive Phragmites, Dog-Strangling Vine, and Garlic Mustard on KLT’s protected lands.
- **The planting of 1,000 potted wildflowers** to support at-risk pollinators.

Additionally, your gifts go the extra mile, or should we say acre, through our growing Partners in Conservation program. Through your support, we’re able to collaborate with private landowners on stewardship projects that make a difference for nature in the Kawarthas.

We’re excited to share with you that we reached the 100-member milestone by the end of 2024! Through the program, we collaborated with landowners on 60 stewardship projects in 2024 that supported nature on our shared landscape.

Thank you to donors like you and The Michael Young Family Foundation for supporting this important and growing program and to our PIC members for caring for their lands, which contribute to the overall health of the region.

Only 1–3 percent of the original extent of tallgrass prairies remain in Ontario. Tallgrass prairies are one of the rarest ecosystems in North America.

Leaving a Natural Legacy

Our Cedar Stand Society is a group of passionate nature lovers who have generously chosen to give a gift through their wills to support Kawartha Land Trust’s conservation efforts in the Kawarthas. Their future gifts will ensure the protection and care of the natural and working lands of the Kawarthas for future generations.

The rolling green hills of the Bethany area in Kawartha Lakes are breathtaking. And in that verdant, picturesque landscape is Sheidow Farm — a 200-acre farm that was protected in 2017 through a conservation easement agreement by owners Ron Awde and Robert Ertel.

The property lies on the north edge of the Oak Ridges Moraine and features a small spring, creek, wetlands, forest, and vital agricultural land. 120 acres of the property’s woodland corridors are being carefully restored to improve the health of the forest and wildlife habitat.

Ron and Robert have made many important contributions to conservation in the Kawarthas. They protected their farm with an easement in 2017, are incredible caretakers of their land having planted over 75,000 trees, are members of KLT’s Partners in Conservation program, and are monthly Pollinator donors, helping to support KLT’s core conservation work. Ron also served as KLT’s Chair of the Board from 2013–2014.

Time spent on family farms while they were growing up instilled a deep respect for nature and a responsibility for nurturing it that is still evident in their care of the land today. Among their many commitments to nature is a legacy gift to KLT to help us maintain the lands already under our care and protect new nature reserves.

“Legacy giving allows us the ability to give more to organizations we are passionate about,” they shared. “We have a supportive family who also understand the importance of conservation to us and the need to invest in the community interest.”

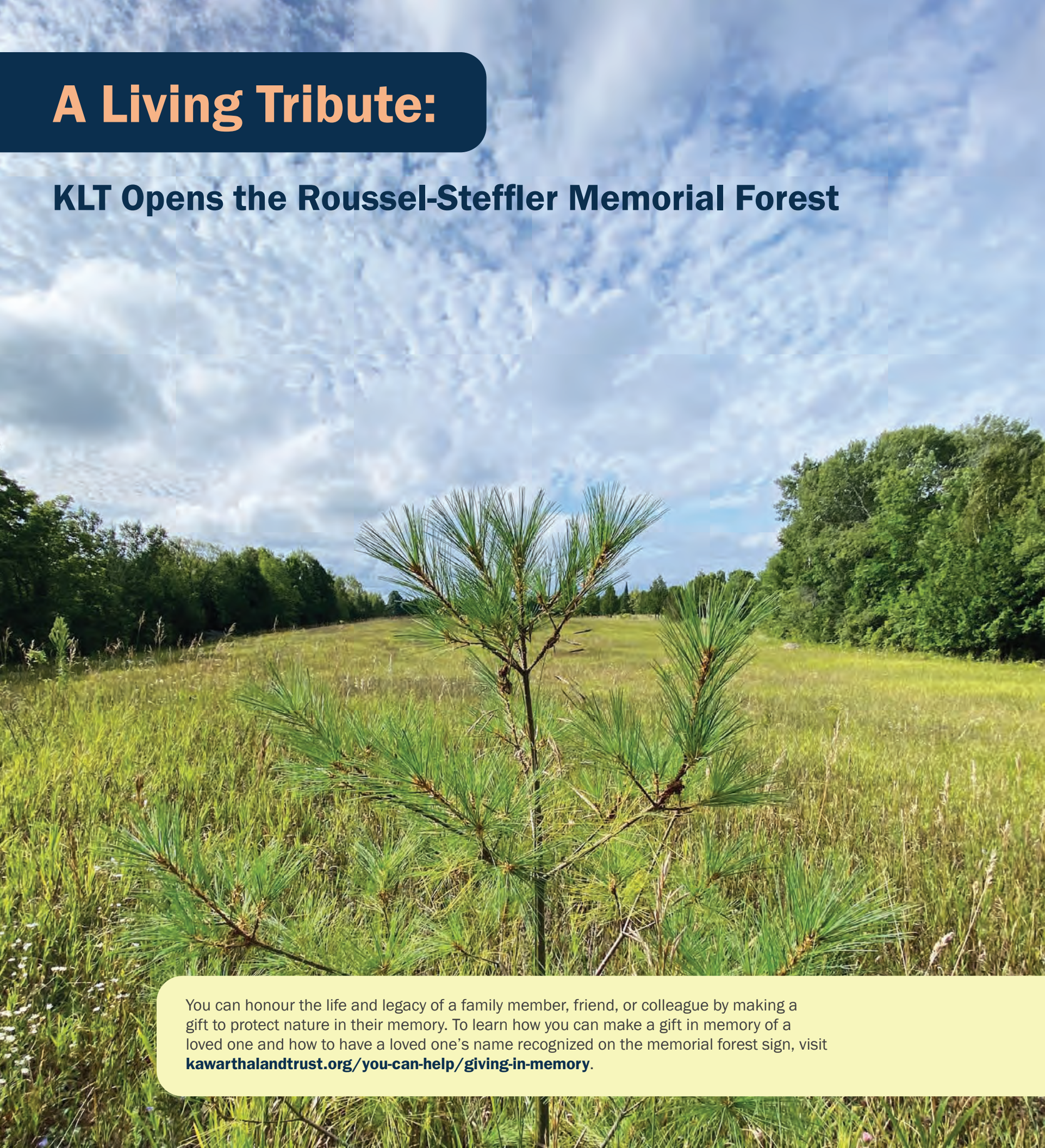

KLT Opens the Roussel-Steffler Memorial Forest

On September 27th, 2024, Kawartha Land Trust (KLT) held an opening ceremony for its newly established memorial forest – the Roussel-Steffler Memorial Forest, located in the heart of Douro-Dummer Township in Peterborough County.



The memorial forest is situated within one of KLT’s recently protected nature reserves, the 102-acre Roussel-Steffler Memorial Sanctuary. The nature sanctuary, which protects forests and a section of a Provincially Significant Wetland, was generously donated to KLT in 2023 by the Roussel-Steffler family in honour of late husband and father Paul Roussel who loved and cared for the land for decades.

The 2024 memorial forest plantings and future plantings of native trees, shrubs, and wildflowers in the retired agricultural field will continue the Roussel-Stefflers’ long-time stewardship of the property. The native species planted will grow into one thriving ecosystem that supports biodiversity, provides vital wildlife habitat, and contributes toward natural climate solutions for the region.

Volunteer Impact

Volunteers bring our work to life. In 2024, Kawartha Land Trust's incredible volunteers contributed over 5,200 hours of volunteer time — a testament to the passion and dedication of our KLT community.

Our Property Inventory Team (also known as the PIT Crew) completed 25 inventories covering over 3,600 acres. The information they gather gives us a better understanding of the lands we protect and are working to protect and support our Partners in Conservation program. Our Event Ambassadors helped make 13 Passport to Nature events a success and supported public outreach at events throughout the Kawarthas.

Our Lead Property Stewards monitored and cared for thousands of acres of KLT's protected lands, while our Stewardship Volunteers removed invasive plant species, conducted species surveys, cared for our public footpaths, and supported stewardship projects to help make our landscape more resilient. Our Trustees and Board Members help guide us to reach our strategic goals and fulfill our vision and mission.

From GIS volunteers and event reporters to volunteer photographers and fundraising volunteers, the skills and knowledge of our volunteers make us stronger. **Thank you!**

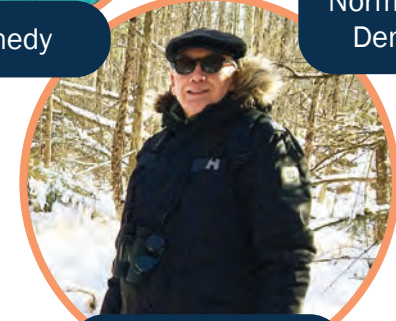

A Message from KLT’s Treasurer

Kawartha Land Trust has successfully completed its 24th fiscal year of preserving land and advancing conservation through land stewardship, management, education, and public engagement in the Kawarthas. Additional land donations valued at \$1,414,000 were received this year, and additional stewardship funds of \$1,764,000 were donated in the year which brings our totals, since inception, to land investments of \$31,535,000 and stewardship funds of \$4,135,000, which allow us to care for our protected lands in perpetuity.

Since we have no long-term debt, our Statement of Financial Position (balance sheet) is strong with equity of \$36,328,000, an increase from last year of \$4,019,000 and an increase since 2019 of \$23,776,000. Our operations show that we have increased our Invested in Protected Lands Fund by grants and donations of \$4,128,000 during the current year. Our Operating Fund has been able to support our securement efforts and our Stewardship Funds through an additional \$548,000 for the 2024 year.



Our Annual Audited Financial Statements are audited by MNP Chartered Professional Accountants as overseen by our independent Finance and Audit Committee. These financial statements are available on our website. Investments are managed by CIBC Wood Gundy and are overseen by our independent Investment Committee, in accordance with our investment policies.
